



## TOUR CONDITIONS

**SHOWCASE PRODUCTIONS THEATRE TOURS** is a division of **SHOWCASE PRODUCTIONS SOCIETY** which is a "not-for-profit" community theatre organization dedicated to showcasing and developing community talent. Theatre tours help finance our scholarship and sponsorship program, providing financial assistance to students pursuing studies in any aspect of the performing arts. Your purchase of travel services from Showcase Productions acknowledges your acceptance of these terms and conditions.

**REGISTRATION** for our tours must be made directly with **SHOWCASE PRODUCTIONS** and must include the required deposit. Tours which may be cancelled by **SHOWCASE PRODUCTIONS** will result in a full refund of the required deposits. Final payment is usually due 30 to 45 days prior to the commencement of the tour. Acceptable forms of payment are by money order or cheque. *Sorry, we do not accept credit cards and prefer not to accept cash payments.*

**MEDICAL & CANCELLATION INSURANCE** is **NOT** included as part of the tour and should be purchased at time of registration.

**TOUR PACKAGES** vary as to what is included in the total price. Services included in the tour are identified in the itinerary.

**HOTEL ACCOMMODATIONS** are available for a single, twin/double, triple or quadruple basis. Naturally, the more people sharing a room reduces the individual's costs. Please note that triples include two beds for sharing. Accommodations, as requested by the traveller, will be provided whenever possible. Hotel gratuities are included in the price of the tour and provide for the

handling of one suitcase per person. Additional suitcases, if allowed, will require an additional charge. There is no charge for carry-on cases handled by the traveller. If the cancellation by one or more passengers alters the rooming arrangements previously requested, passengers still travelling must pay the applicable rate of the revised accommodations. If, after the tour departs, services included in the tour cannot be provided, or changes to the itinerary are necessary for reasons beyond the control of the tour escort, **SHOWCASE PRODUCTIONS SOCIETY** will arrange for the provision of comparable services. Any resulting savings experienced by Showcase Productions will be passed along to the tour participants. Any additional costs incurred will be absorbed by the Society.

**PROOF OF CITIZENSHIP** (including children) for all trips outside of Canada is required. Passports and Visas are the responsibility of the traveller. Persons taking children, for which they do not have legal guardianship or custody, must carry with them appropriate consensual documentation.

**SMOKING and the DRINKING of alcoholic beverages** on coaches is strictly prohibited, however, stops are provided approximately every two hours. Smoking/non-smoking hotel rooms may be requested when registering for the tour. However, they are subject to availability and restrictions imposed by the hotel.

**OUR MOTORCOACH TOURS** use only modern, air conditioned coaches provided by an Atlantic Canada coach charter provider. To ensure fairness, coach seating may be rotated daily, at the discretion of the tour escort. The customary tips to tour escorts and drivers are discretionary and should be extended on an individual, voluntary

basis. Group collections for tips are **not permitted** and will not be tolerated.

**Any CANCELLATIONS** by participants must be received by **SHOWCASE PRODUCTIONS SOCIETY in writing** and are subject to the following penalties:

- a) 90 days or more; full refund, less non-refundable deposit;
- b) 60 days or less; 40% refund of the total tour price;
- c) 29 days or less; no refund.

**SHOWCASE PRODUCTIONS SOCIETY** acts only as an agent for owners/contractors who provide transportation, accommodations or other service and therefore, shall not be liable in any way in connection with loss, damage, injury, delay or accident due to any default on the part of a company or person engaged in any tours.

**SHOWCASE PRODUCTIONS SOCIETY** reserves the right to withdraw any tour, or any part thereof, and to make alterations as may be deemed necessary by **SHOWCASE PRODUCTIONS SOCIETY**. The Society reserves the right to decline or accept any person as a member of any tour at any time. Tour escort(s) will be announced at the time the tour is confirmed.
